

Grant Request: Conditions and Rules

- The research projects should be related to cancer disease.
- The research topic can be translational, clinical or of public health.
- A priority will be given to projects involving the development of innovative therapies for patients. Preclinical research should not be basic research but should be as close to the clinic as possible.
- The main applicant (MD, PhD, nurse or else) should demonstrate its ability to lead and to finalize an innovative research project. He/she can cooperate with co-applicants.
- The duration of the grant will not exceed 3 years.
- The proposal should be formulated as a detailed letter of intent.
- The detailed letter of intent should be 5-10 pages, Arial 11, simple space.
- The letter of intent should include on the front page a summary of the project. It should then give a complete description of the project, in the context of the current scientific knowledge. It should describe the research plan and the used methodology. It should emphasize the significance of the expected results in the current scientific context. It should demonstrate the expertise of the applicants to carry through a project and to publish it. It should propose a detailed budget of the financial needs and mention other sources of financial support.
- The requested grant cannot cover the salary of the main applicant.
- The letter of intent has to be dated and signed by the applicant. A letter of motivation and a curriculum vitae should be also provided. The request should be written in English.
- **All the documents should be sent in an electronic form in one and unique document to: contact@fondaction.ch**
- Further information might be requested after the selection of the project.



- The grant proposal will be assessed by the scientific committee together with external experts.
- The final decision (positive or negative) will be sent by email. The decision is legally binding and allows no course of appeal. Obtaining a financial support is occasional and not obligatory.
- The research project can be chosen following a public call or by direct invitation of scientific committee.
- Any modification of an on-going project should be submitted to the scientific committee.
- The main applicant should be Swiss or be employed by a Swiss institution.
- The financial support will be given only after the publication of a post on LinkedIn that acknowledges Fond'Action contre le cancer.
- It is suggested to inform the direction of the Institution concerning the support that is received.
- An interim report describing the progress of the project and the financial status must be sent once a year, before September 15th in an electronic format to: contact@fondaction.ch . Any breach of his rule can lead to the termination of the grant.
- A final report should be sent in an electronic form before September 15th with a copy of the publications, abstracts, and/or any other public documents that have been produced. The financial report should be certified by the official authorities of the main applicant.
- If the grant is not used for the project according to the conditions defined for its allocation, Fond'Action reserves the right to require a partial or full refund and to take all measures it considers justified.

**Motivated applications
must be submitted no later

Funding up to 1 million Swiss francs will be awarded to support translational, clinical, psychological, and public health research. Applications must clearly describe the significance of the expected results in the fight against cancer and in the care of patients.

- Applications must include the research plan, a CV, a list of publications and detailed financial needs.
- The duration of the grant may not exceed three years.
- Applications must be submitted in English.
